- 2. EN ISO 1716:2010 Reaction to fire tests for products Determination of the gross heat of combustion. (Calorific Value)

# Mounting and fixing (For EN 13823:2010+A1:2014):

The specimen was tested free standing at a distance of at least 80 mm from the backing board. Both wings were clamped at the top and the bottom.
